U22 (born between 2004-2009)

(P10) Special Ranking PATU U22 (classifying)(P4) Open Poomsae Categories

#### 7. Competition Rules:

WT Rules & Regulation must be applied

# 8. COACHES

Coaches must have a Valid WT Level 1 or 2 license, or have passed the PATU Coaches Seminar





### 9. Competition:

#### **KYORUGUI / POOMSAE**

 No restrictions on number of participants per country per division (As long as they meet the competition requirements)

#### KYORUGUI

4 World Weight Categories per gender for a total of 8 categories

#### POOMSAE

Recognized Poomsae Individual Male & Female Recognized Poomsae Mixed Pair Recognized Poomsae Team (3 same gender) Freestyle Individual Male & Female Freestyle mixed team (5) Freestyle mixed pairs & Individual recognized poomsae (male&female) (qualifying category for JPJ Asuncion, 2025)

#### Important notes.

Based on the classifying Rules

- 1. Any athlete who does not have minimum 3 PanAm Series U22 events, shall not be eligible for the classification.
- 2. The spots obtained through classifying ranking process are for the athlete, not for the country, the spot gained is nontransferable.
- 3. There will be a maximum of one classifying athlete per country

#### **10.** Competition Time:

Kyorugui

Best of 3 rounds (2 minutes x 2 or 3 rounds x 1 minute break) Times may only be adjusted by the WT TD (Technical Delegate)

#### Poomsae

Recognized Poomsae no more than 90 sec Freestyle 90 – 100 seconds





#### 11. Awards:

# Ranking points (as per #6)

Medalls1st, 2nd & 2 and two 3rd places; Digital certificates for all participants.

# WILD CARDS

Winners of the first 8 qualifiers to the Junior Pan American Games Asuncion 2025, will win a WILD CARD for the next Pan American G4 and for the next Nations Cup.

The winners of the first 8 spots in all categories of these final Panam Series U22, will get a WILD CARD for the next Pan American G4 and for the next Nations Cup, taking into account a maximum of 1 WILD CARD per country will we granted.

If any athlete does not meet the age to participate in the next Pan American G4 or Nations Cup, because he/she is under the minimum age in the Senior competition then he/she will be able to use this wild card in the next event.

### 12. Classifying process for Pan American Junior Games Asuncion 2025

Athletes who compete in these Games will gain Ranking points for the Pan American U22, which will give them the opportunity to classify directly to the **Pan American Junior Games Asuncion**, **2025** (see rules )
