Minutes of the Pan American Taekwondo Ordinary General Assembly, held May 1st, 2022

Punta Cana, Dominican República at 03:00Pm local time, on the Sunday 1st of May of 2022, at the Convention Center of the Hotel Barceló Bávaro, placed in Carretera Bávaro Km. 1, Playa, C.P. 23001, República Dominicana the Ordinary General Assembly of 2022, of the Pan American Taekwondo Union (therefor PATU or Union) took place.

According with the Organization Statures, the meeting was presided by the President Mr. Juan Manuel Lopez Delgado, as chair of the council meeting of PATU.

Mr. Mario Mandel took the role of Secretary as part of his role of Secretary General of the PATU Council.

After the roll call the Quorum was confirmed accordingly to the article 16.1 of the PATU statutes. The meeting took place on site and additionally members could join through remote connections, the quorum was reached.

Meeting Development:

Point I. Roll Call

The secretary general verified the people present and the attendance list of the council members present at the meeting.

Point II. Confirmation of the Quorum.

The President of PATU, after his welcome speech requested the Secretary General to confirm if the quorum was reached, according to the quorum specification mentioned on the statutes. After the quorum was confirmed, the president officially opened the **2022 PATU General Assembly** and started with the agenda for the day.

The Secretary General Informed that according with the attendance list, there were present **42** members of the General Assembly, due to that quorum was reached and PATU General Assembly could proceed

According with the attendance list verified by the secretary, it is confirmed that quorum was reached, and the Ordinary General Assembly could proceed

Point III. Welcome speech of the president and opening of the meeting

The president welcomed all the members and in virtue that the required quorum was reached, he declared on Sunday 1st of May of 2022, at 03:05 pm local time, that the 2022 Ordinary General Assembly of the Pan American Taekwondo Union officially opened. All the agreement reached during the meeting would be valid

Agreement 1 – 2022 PATU General Assembly Official Opening of the Meeting

"Being 15:05 pm on May 1^{st} , 2022, I officially declare the 2022 Ordinary General Assembly of the Pan American Taekwondo Union open, and declare that al the agreement reach by this meeting will be valid for all the members present and absent"

It was informed by Secretary General that in regards point IX of the agenda, there were non requested topics. After that declaration, the agenda was submitted to the General Assembly, and it was approved unanimously in the terms presented. With the approval the following agreement was adopted:

Point IV. PATU President's Report – Mr. Juan Manuel Lopez Delgado

PATU president presented to the General Assembly his report of 6 month of his term. It was informed that the organization has archived many milestones with organization, transparency and hard work that had and will beneficiate all PATU Membership; organize and create procedure for financial accountability, create better relations with WT along with improve the relation with other sport organization of the continent and region, as has been a few of the milestones archived.

He also highlighted that it has been reach a Continental Union, that works under the principals of transparency, unity, and accountability. The detailed information about each one of these topics can be found on the <u>Annex 2</u> of this minutes.

PATU Auditor presented to the General Assembly his activity report along with the revision and approval of the Financial Statements of the Union, acknowledged that the reports followed the general principals of the accounting, and the principals followed by this administration in terms of transparency and accountability.

Acknowledging the transparency showed in the management of the resource by the administration and the Council."

Point VIII. Updates and ongoing work regarding Events: Central American Games 2022, Central American and Caribbean Games 2023 and Olympic Games 2024.

The president informed that a hard working has been done for the Central American Games 2022, same as with the Central American and Caribbean Games 2023, so this events can be done in the best way possible. He also informed that due to agreements adopted by the respective NOC, the Central American and Caribbean Games 2023, will take place in Dominican Republic instead of El Salvador.

The host for the qualification tournament for the Central American and Caribbean Games will be decided soon and the event had to take please no later than February 2023.

The qualification tournament for the Pan American Games, will take place in Rio de Janeiro, Brazil, in March 2023.

In regards of the Qualification Tournament for the Olympic Games, it was informed that the date will be analyzed depending on the option available, and it was determinate that the deadline to determinate the host will be July 2022.

The Secretary informed that there were no requests for additional topics to be included in the agenda, by the MNAs or the PATU council members.

Transparencia

Clear and Transparent Event Bidding Process.

- The bidding information was sent to all the MNAs to give equal opportunity to all.

Reactivation of Committees

- 14 Committees were created.
- 5 Special Committees were created to help with the re-activation of PATU.

Creation of Adminitrative and Operative Structure.

- There is an Adminitration, the Secretariat and Event team that works 24/7.
- It was defined the operation and the support need it for those countries that have the first experience as LOC.

Creation of internal rules and regulations

- The rules for Council Meetings was created
- Voting Code.
- Event Bidding Process.
- And currently working on the review of the rule for International Events in PATU.

Creation of the IR structure

- The structure reflect the division per regions and competition areas.
- A list of IR were created to have a data base to assign the IR for PATU events.
- A Education group was created to guaranty the training of new IR and the refresh of the current ones.

- Work along WT for the Habana Open.
- Research to create a strategy to increment the Licence number in the Caribbean and central American region. Impulso a justas regionales y continentales

- Improvement of relation with other regional sport organization such as ODECABE, ODESUR, ODEBO.

Creation of the Pan Am Series Events

- First Event series in the region
- Grants Wildcard for the Pan American Championships.

Creation of the Grand Prix Pan Am

- The event will gather the best athletes of the continent
- It will happen in non-pair year, after the close of the Olympic cycle.

WT-PATU Project

- 3 development Project were presented
- In constant communication with WT departments.

Application of the last updates in the competition rules.

- Since the approval of the update on February 16th, 2022. PATU have encourage que application of the new rules in the event in the region.
- The Puerto Rico Open was the first event with application of the new rules in the continent.
- During that event the WT Referee chairman and Technical Chairman were present.

Clear Accouting

Transparency in the presentation of the Account reports

- This adminitration is the first one with clear record of their finances and accounts.
- The Process to present and report the budget for 2022 was clear.

Clear Hostings fees

- It's included in the bidding Process by rule.
- All the countries can apply to be the host of one of the events.

Event Agreements

- Before the events take place the LOC and PATU had several meetings to agree on the requirements, need and the opportunities of the LOC.
- The agreement between LOC and PATU, are put in writing.

Event Calendar 2022

- For the first time the Pan Am region had an event calendar.
- The communication with WT in regards Event is open and fluent.
- The Communication had a new portal PATU website www.patutkd.org that has become the main tool of communication of the Pan Am community.
- Through the website and the social media, we reach the MNAs and the technical groups.

We have done unprecedent changes, nevertheless, there is a lot more to do. We must work

hard as a team, as a Continental Union to position PATU as a TOP in the world.

Secretary General Report – Mr. Mario Mandel Vaisman.

PATU STRUCTURE – GRAPHIC GOALS

Since the election, the secretariat has focused their efforts on solving the issue we know we had and that were confirmed by national federation, as a concern of them regarding former administrations

- Communication
- Improve the times of reply and the interaction between the office and the members
- Transparency and the fair distribution of the information regarding events and biddings
 - Events Bidding Processes
 - Procedure standardization
- Website updated

STRATEGY

To solve each one of the items mentioned above, a strategy has developed, all of them with the goal of maximize participation of the Member National Associations (MNAs), and that all of our MNAs can have the same opportunities, without forgetting the transparency of the process

COMMUNICATION

The first move of the Secretariat was to focus on communication improvements, thinking the communication as a howl. Setting the target as replying to the queries, and emails within 72hrs. Up to this date, we have reached that time of reply. Additionally, PATU has invested in created a communication department that is charge of the communication in social medial, which has greatly improved the position of our organization at international level; because the information posted in social media not only reach our members but also the international community.

The change has been noticed, not only the amount of information available has increased but also the aesthetic in the way that information is presented had improved, which has granted compliments.

All this individual improvement sums up and create the increase of the number of registrations in our events, and this increase it is not only in the number of athletes and official but also the number of the MNAs from where these participants came from.

RESPONSE TIME

The increase on the information available plus the increase of involvement of the number of MNAs with the organization and its activities has increase of queries, emails and question that requires answers. But we are glad to inform you that the response time has been kept within our target and in same case has improved.

The communication with WT is the best that his organization had has from years, this is easy no notice if we look in the time phrase that events are approved but also in the increase of education course dictated in Spanish.

PROCESSES

If we move to Event process, the current OC could ratify that the office had an ongoing communication, since the first step, by sending the bidding process and information to all PATU membership, so they can easily create the proposal to the last step that is help with OC to run the event. The office has worked side to side with the Local OCs and has helped to find solutions. Today we can gladly say that this year many MNAs will host international events for the first time, and we are proud it.

STANDARDIZATION AND PROCEDURES

Finally, the office had worked hard and have invested many hours in create process and review and standardize existing ones. So, each one of our operations can be accomplish with transparency and democracy. To mention an example Committees has been created and each one of them is rule by their own code – TOR, this allows the members of the committees to have a rule framework that brings them security and confidence to fulfil their duties.

PROCESS STANDARDIZED

The process has been also standardized, for example the event bidding process and now we are working to standardize other process such as, procedure manual for events, e-vote code, with the aim that the rules mentioned on out statute can be easily applied in our day-to-day operations.

OPEN AND INCLUSIVE PARTICIPATION

Our organization has also open in terms of given voice to all the members; this is a very complex organization with many different realities, due to that this is a key point to successful governance. In this sense we have implemented meeting with the national coaches, presidents, event organizers with the aim to listen all the people that is involved in our organization.

WEBSITE AND SOCIAL MEDIA

Our website has served as a link to other important organizations, such as: ACODEPA, PanamSports, CON, who has congratulated us not only for the aesthetic of the design but also for the quality of it, and that is always up to date.

FINAL CONCLUSIONS

To summarize, this past month has required long hours of work, each one of the documents you have received reflect hours of preparation, effort, collaboration, but we are glad because this has created the bases to a new PATU, that will be our legacy and an example in a near future. We are strong because we have your support. This is a new era for PATU, in which the doors are open for all the people that want to work, collaborate, and give. The Secretariat has been and will continue being the link between all of us, so we can reach of goals, because communication is the base to give them all the same opportunities.
